RULES OF AUDITIONING

1. I have made all the necessary disclosures and have answered all of the questions on the application form completely, honestly and accurately and I confirm I have not misled or attempted to mislead Stats Media in any way as to my identity, experience or affiliation to a Modeling School or Modeling Agency or in any other way.
2. If any of the information I have given in the application form is found to be false, Stats Media will be entitled to exclude me from the West Africa Next Top Model 2009 contestant selection process.
3. I am between the ages of 18 and 25 (as of 1st January 2009).
4. I am in possession of a valid passport or identity document and understand and agree that if I am selected to participate in the West Africa Next Top Model 2009, I will be required to produce my valid passport or identity document at the auditions.
5. I understand and can communicate in English.
6. If I am short listed at auditioning, I am prepared to undergo psychological and medical screening. I understand that the full details of this will be explained to me in advance.
7. If I have children and am selected as a contestant in the Competition I agree that my children will not be able to reside with me at the West Africa Next Top Model 2009 locations; and no responsibility with regard to the welfare or accommodation of my children.
8. Even if I am selected as a contestant, Stats Media have no obligation to produce the West Africa Next Top Model 2009, and even if the West Africa Next Top Model 2009 is produced there will be no obligation on Stats Media, its affiliates or any broadcaster to broadcast it.
9. If I am selected as a contestant I agree that I am able to travel as an individual or with a chaperone as appointed by Stats Media LLC to the locations of West Africa Next Top Model between January 2009 and April 2009, (or for such other period as True Stats Media may designate).
10. All decisions by Stats Media concerning selection of the contestants are final and binding and no reasons will have to be given for these decisions. I agree not to challenge or appeal against these decisions.
11. I hereby assign irrevocably to Stats Media the entire copyright and all other rights of whatsoever nature in and to my audition and contribution to the West Africa Next Top Model 2009, whether now in existence or arising in the future, including without limitation, my performance, any comments ascribed to me (whether as part of an audition, any interview or "backstage") and any inclusion of my names, image, voice, soubriquet, likeness and/or portrait, howsoever caused, which assignment Stats Media accepts. Stats Media shall therefore be entitled to use and exploit and license others to use and exploit such contributions, in whole or in part, by all means and in all media, manner and formats whether now known or hereafter invented throughout the world and in perpetuity
12. I grant Stats Media an irrevocable performer's release and state that Stats Media may photograph, film, record, edit, broadcast, re-broadcast, publish or communicate to the public my performance, including for promotional purposes, related to West Africa Next Top Model 2009, without remuneration.
13. I hereby indemnify Stats Media, subsidiary and affiliated companies, their officers, agents, directors and employees against any costs or damages (including consequential damages and pure economic loss) that may be incurred by Stats Media as a result of claims or charges made against Stats Media (whether at the instance of a third party or myself) for infringement of any right, whether the claim or action arises from elicit or contract, or any infringement of whatsoever nature, arising out of or pursuant to the exercise by Stats Media or myself of its/his/her/my rights or the fulfillment or breach by myself of my obligations in terms of the West Africa Next Top Model 2009, Stats Media, and such indemnity shall extend to the reasonable costs that may be incurred by Stats Media in defending any action instituted against it.
14. I agree to make myself available for interviews, auditions, publicity, and any other event relating to West Africa Next Top Model 2009, and to do what is reasonably expected of me to assist Stats Media with all the arrangements necessary for the Competition.
15. I will keep strictly confidential and will not, without the prior written consent of Stats Media, at any time from the date I sign this entry form and thereafter for twelve (12) months following the first transmission on television in Africa of the final episode of West Africa Next Top Model 2009; disclose, publish or reveal to any person any incident, conversation or information concerning the Competition or the application/selection process or my appearance (if at all), which comes to my knowledge as a result of my inclusion in the contestant selection process and/or the Competition (if selected) nor other information relating to Stats Media or West Africa Next Top Model, which comes to my knowledge during this period, other than information already in the public domain. Should I be approached or contacted by the press, I shall immediately refer them to Flair or the Executive Producers – Stats Media, LLC.
16. If I am selected to compete for the West Africa Next Top Model 2009 by Stats Media, I will be required to enter into a formal written agreement with Stats Media and/or any other relevant party, the terms and conditions of which will be necessary to protect the rights of Stats Media and/or such other entity involved in the production. Should I choose not to enter into such formal written agreement, I acknowledge and agree that I will be disqualified from participating in West Africa Next Top Model 2009.
17. If I emerge as the winner of the West Africa Next Top Model 2009, I will be required to enter into a formal written agreement with the Modeling agency chosen by Stats Media and should I choose not to enter into such formal written agreement, I acknowledge and agree that I will forfeit all expected prizes promised at the onset of the competition.
18. I am not an employee of, or related to an employee of, Stats Media, its subsidiaries, affiliates, partners or the selected Modeling agency.
19. I have not entered into any contractual, commercial, sponsorship or other arrangements nor have I entered into or will enter into any contractual, commercial, sponsorship or other arrangement in respect of my possible appearance in West Africa Next Top Model 2009 and such that would be in the conflict of interest regarding the West Africa Next Top Model.
20. I will not engage in any photographic sessions in relation to West Africa Next Top Model 2009, with any third party without the prior written consent of Stats Media LLC.
21. I warrant that I understand and accept these rules, that I have no legal obligations which conflict with the making and signing of this application in accordance with the rules.
22. Neither Stats Media, its subsidiaries, partners, affiliates or sponsors shall be liable for any damage or loss arising out of my participation in, or the performance of my obligations as a contestant in the West Africa Next Top Model 2009.
23. Stats Media shall be entitled to disqualify me from West Africa Next Top Model 2009, and/or terminate any contractual arrangement I may have with Stats Media and/or any other relevant party at any time and without compensation, should I, at any time:
 - i. supply, or be found to have supplied untruthful, inaccurate or misleading personal details and information; or
 - ii. be found to be unfit, in the sole discretion of Stats Media, as a result of any illness or and other physical or mental condition; or
 - iii. breach any of the Application Rules or behave in a way which the Producers in their sole discretion, consider inappropriate; or
 - iv. elect not to enter into the formal written agreement referred to in clauses 16 and 17 (in the event that I am selected to participate in West Africa Next Top Model 2009).
24. Should Stats Media decide, in their sole discretion, not to proceed with West Africa Next Top Model 2009, Stats Media shall elect to terminate this Entry Form without compensation to me.
